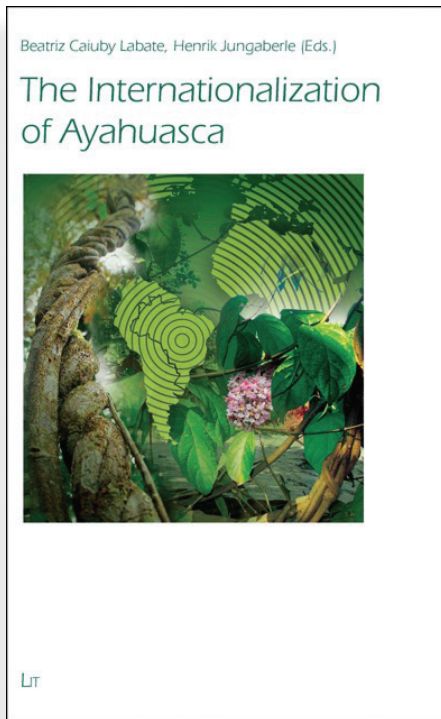


# BOOK RELEASE

## The Internationalization of Ayahuasca

**T**he *Internationalization of Ayahuasca* is composed of 27 articles (almost 500 pages) and is divided in three parts: “Ayahuasca in South America and the world”, “About medical, psychological and pharmacological Issues: is the use of ayahuasca safe?” and “The expansion of the use of Ayahuasca and the establishment of a global debate on ethics and legalization”. The book brings together the work of scholars from different countries and academic disciplines to offer a comprehensive view of the globalization of this Amazonian brew. It presents a rich array of reflections on the complex implications of this expansion, ranging from health, spiritual and human rights impacts on individuals, to legal and policy impacts on governments. As ayahuasca drinking becomes an increasingly established practice beyond the Amazon in the early 21st century, Labate and Jungaberle have put together a collection that is an unprecedented contribution to a growing field of research. It is a must-read for people interested in the present and future of ayahuasca, as well as in spirituality, ethnobotany, social science theory, contemporary religious and ritual studies, therapeutic potentials of psychedelics, and international drug policy.
